Appendix 1

"Following discussions with officers this afternoon, we can yet again confirm that there is no prospect of the AVBC land on field lane being used for the purpose of a toilet and office site for the private rail franchise East Midlands trains, Belper Town council or anyone else. Full council has recently passed a motion to repurpose this land for 100 extra car park places, and that is what we will be doing. We note that an online petition was raised against this decision, and that this attracted just 12 signatories.

We are disappointed that Cllr Porter, who wrote this report, did not see fit to speak to the Cabinet member responsible regarding the use of this land, but we are afraid that this follows the pattern of the Belper neighbourhood plan, which also made plans for this AVBC land, but again didn't speak to Amber Valley Borough Council regarding their plans. Had they done so, then a lot of wasted work could have been saved. We also note that this current paper does not fit into the draft Belper Neighbourhood plan either; and the proposal would not currently be legally compliant, as all new Toilets are expected from early next year to be Changing Places (<https://www.gov.uk/government/news/changing-places-toilets-for-severely-disabled-people-to-be-compulsory-in-new-public-buildings>) but that is moot, as these plans will not be happening.

We would respectfully suggest that BTC could explore possibilities with the land owner at the top of platform 2, should they be minded to spend public money to build toilets and an office for this private rail franchise.

For information, we can confirm that officers in the regeneration portfolio are meeting with East Midlands Trains, to discuss the making of the new entrance through to platform 1 from the car park. There will be no meeting with BTC, DCC, EMT and AVBC on our land, and we consider the matter of this scheme or any other for this land, owned by AVBC, put forward by Belper Town Council, now closed.
