The Assistant Clerk advised that AVBC were still unable to provide a quotation for the provision of a CCTV camera in the Memorial Gardens because of changes to their procurement processes. It was hoped that they would be able to do so within the next few weeks, and a further 2 quotes would also be sought. The Committee were also made aware of a number of recent complaints from residents regarding anti-social behaviour and drug taking as well as three serious assaults around the top of King Street, over the past month.
